SECRETARY'S REPORT

Responsibilities:

 Record the monthly meeting minutes and post them to the WriteBoard for review by the board members who have the option to edit and modify the minutes. The WriteBoard retains all versions of changes made. Once the minutes are approved by the Board, they are published in the Reader.
Prepare ballot for annual election and receive/count any snail mail ballots.

Activities:

This year we had three Board Meetings for which minutes were prepared and posted to WriteBoard for editing and, once approved, using electronic voting, the minutes are incorporated into the Reader (CLD Newsletter).

Periodically we have email (electronic) discussions on a variety of topics and, occasionally, voting is required and recorded. Electronic discussions continue to appear in many of the meeting minutes this year. These are often driven by decisions that must be made prior to our next board meeting.

Our June meeting welcomed a discussion as to the frequency of the meetings (monthly) and the challenge for members to be present at board meetings. Members are attending more and more shows, impacting their availability for meetings. Also discussed was a review of the content and frequency of the Reader, our newsletter. The conclusion was to discuss issues electronically, when possible, giving board members a bit more flexibility in conducting board business. Board meetings would be called when needed. The Reader would be published based on availability of content.

17 members exercised their voting option and submitted their ballots. That is an increase of one additional vote over last year. The voting was unanimous and the new slate of officers was accepted. The 2020 slate of officers are Teresa Litchfield, President; Casey Eiten, Vice-President; Katie Keim, Treasurer; & Leslie Burket, Secretary. The new officers will be announced at the Awards Dinner on November 2nd. There were no known snail mail ballots.



WEBMASTER REPORT

The CLD Website, accompanying e-mail newsletter, and FaceBook pages continue to be a popular resource for dressage enthusiasts in the central Illinois area and beyond.

Traffic & Referrals

As in years previous, the CLD website gets its highest level of traffic around the time of CLD Classic. While we get 92% of our web traffic from the US, we enjoy single digit percentage traffic, or less, from Canada, China, the UK, Australia, India, Germany, the Netherlands, Poland and the Philippines in order.



Facebook & Twitter

CLD's FaceBook page continues to grow people with 700 people "liking" CLD, up from just over 670 the previous year. CLD's Twitter has 44 followers, down slightly from last year. CLD's Facebook efforts are spearheaded by Jordan Wilton and occasionally assisted by Martin Kuhn.

E-mail Update Newsletter

From November 1, 2018 to October 31, 2019 we've sent out 6 email newsletters, down from 9 last year, to as many as 141 subscribers, down slightly from last year. The current number of subscribers stands at 140. The rate of subscribers opening the emails ranged from 55% to 40%, a 52% average is about what we did last year. Additionally we're getting anywhere between 35% and 13% of people opening the emails actually clicking on links inside the emails.
