PRESIDENT'S REPORT

My first year as President started off with me learning the duties of the office. Thanks Judy for all your help in this transition. Then COVID-19 hit and I found myself in uncharted territory. USDF, USEF and all GMO's were right there in the soup with us. There is nothing in the By-Laws on how to deal with a pandemic.

We cancelled IceBreaker, our first schooling show in May because Illinois was not allowed to have any gatherings greater than ten people. USDF/USEF had opened up the show season with strict guidelines in June. However we felt that the risks were far too great at this time, so the board decided to cancel Classic I and II, which were scheduled for June 20 & 21st. We did hold FireCracker in July at TowerHill following USEF/USDF Covid guidelines. The show was small but still successful.

Membership in 2020 was down by 19 members from 2019. I would like to think this was due to the pandemic. I am hopeful that 2021 will show an increase.

In February before COVID-19 hit the United States hard, CLD held a Valentines Potluck/social at Pratense Farms. The night was filled with great food, interesting conversation and fun games for lots of laughs.

With many shows being cancelled this year, CLD did change some of the requirements for our awards this year. We dropped the volunteer hour requirement for all awards. For the schooling show division, we allowed members to use two scores from one show, mainly because schooling shows were hard to come by.

USDF had a schooling show division this year, where participants could submit scores from non-rated shows for year end awards through USDF. These year end awards are separate from those of rated shows. GMO's could also register their schooling show with USDF. CLD registered both IceBreaker and FireCracker this year.

With the uncertainty of the date our nation will return to "normal", 2021 is hard to predict. I choose to be optimistic in that we will be able to hold all of our shows and restore our membership. I still would like to increase our youth membership.

SECRETARY'S REPORT

Responsibilities:

- 1) Record the monthly meeting minutes and post them to the WriteBoard for review by the board members who have the option to edit and modify the minutes. The WriteBoard retains all versions of changes made. Once the minutes are approved by the Board, they are published in the Reader.
- 2) Prepare the ballot for annual election. Acknowledgement of receipt for each received ballot is sent to the voter.
- 3) Frequently, the board will have business that requires a decision to be made between meetings. That information needs to be included in the meeting minutes of the following month.

Activities:

This year we had eight CLD Board Meetings for which minutes were prepared and posted to WriteBoard for editing. Once approved, using electronic voting, the minutes were incorporated into the Reader, the CLD Newsletter. Of those eight meetings, four were 'virtual' meetings, using either Zoom or CiscoWebx.

Electronic discussions continue to pop up and have all been entered into the appropriate meeting minutes. They were all driven by decisions that must be made prior our next board meeting.

In early March, we learned, as a world, and as a country, we had been exposed to the corona virus, (Covid-19) erupting as a pandemic and altering everything in all lives. The timing was unfortunate



Our new officers are usually introduced at the annual Awards Dinner.
